This addendum and the undersigning thereof constitutes an offer by the customer to add a further vehicle to the already agreed terms and conditions undersigned by the subscriber and further to appoint WT24/7 to provide the tracking services to the added vehicle and once this addendum is signed by the subscriber and accepted by WT24/7 either in writing (via e-mail or fax) or by its commissioning of the product, a binding agreement will come into existence between WT24/7 and the subscriber for the added vehicle. The customer endeavours to provide WT24/7 with the original signed addendum and failure to do so does not constitute the addendum null and void. The adding of the vehicle shall commence on the date of commissioning the unit date and shall endure for a fixed period of 36 (THIRTY SIX) months from the commencement date where after it shall continue indefinitely unless and until it is terminated by either party on the giving of 2 (TWO) months written notice to the other party. The subscriber acknowledges and agrees that the debit order instruction may be amended according to the new contract value of the added vehicle. In the event that the control room receives a Park Alarm exit/ Auto Park exit or any Alert from the Tracker, the Customer will be contacted in order for the Controller to dispatch Run Recovery. If the Customer fails to answer his/her mobile device Run Recovery will be dispatched automatically, if for some reason it is a False Alarm, the Customer will be charged an amount of R 3 500.00 which will be debited from their account. The above does NOT apply to subscribers of Run Recovery.
